Clarifications to queries raised by prospective bidders are herewith issued as shown in the table below:

We are seeking clarification on Section II - Bid Data Sheet (BDS, ITB 12.1(j), Item (f) which states "The firm bidding must be registered with the Land Surveyors Board" The Land Surveyors Board gives license to individual surveyors and not firms.	This is well noted, the Lead Consultant who is a Land Surveyor should be the one registered and not the firm.
3.	Firstly, we would like to seek clarification regarding ITB 11(J) g; The firm bidding must be registered with the Land Surveyors Board. In the case of a JV should the lead firm be registered with the Land Surveyors Board or can this requirement be met by one of the consortium in the JV?	This is well noted, however, the Lead Consultant who is a Land Surveyor should be the one registered and not the firm as mentioned in the bidding document.
4.	Section III Clause 1.1 Adequacy of technical proposal; The Bidder shall demonstrate that it has successfully completed at least Five (5) Contracts within the last Five (5) years prior to bid submission deadline, each with a value of at least Kshs 10,000,000.00 that have been successfully and substantially completed and that are similar in nature and complexity to the Goods and Related Services under the Contract. For a joint venture, this requirement may be met by all members combined. For JV, are all members required to demonstrate this	The total no. of assignments for the JV should be at least 5contracts each of 10Million meaning the total combined experience cost of the contracts should be 50million for the JV partnership and not 10million as you are proposing.
